Topic Mississippi River Bridge Cantilever Platform

SUMMARY

Plans for the development of the OVR trail have included constructing a viewing platform where the trail crosses the Mississippi River. Originally this viewing platform was proposed to be constructed on the south shore. The County has engaged a contractor to install railings along the bridge and work is scheduled to begin this week. During a recent site meeting with the contractor, the contractor suggested that they could construct viewing platforms on the bridge in the middle of the river and incorporate this work into their work to install the railing. They are offering to construct the viewing platform (approximately 8' X 20') on a time/material basis for the estimated cost of \$50,000.

COMMENT

Placing the viewing platform in the middle of the river is ideal for viewing and it would be very convenient to have the platform constructed as part of the railing project. The first draft of the 2018 budget does include \$50,000 for the viewing platform as part of the OVR trail project.
