File No .09-T-12002 – Coleman Street **Subdivision (Nuglobe Developments)** Lanark County is in receipt of an application for approval of a proposed plan of subdivision for property described below. The application was deemed complete by Lanark County on November 12, 2012 in accordance with subsections 51(17) and (18) of the Planning Act.

LOCATION OF PROPERTY


If a person or public body does not make oral submissions at a public meeting, or make written submissions to Lanark County in respect of the proposed plan of subdivision before the approval authority gives or refuses to give approval to the draft plan of

subdivision, the person or public body may not be added as a party to the hearing of any appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.

If you wish to be notified of the decision of Lanark County in respect of this proposed plan of subdivision, you must make a written request to Lanark County, c/o Planning Approvals Department, Administration Building, 99 Christie Lake Road, Perth, ON K7H 3C6, indicating the County file number 09-T-12002.

WINTER PARKING

Any time Environment Canada forecasts a snowfall of 7 cm or more an overnight parking ban will be in effect in the Town of Carleton Place. This includes any forecast that calls for a range of snowfall exceeding 7 cm (i.e. 5 to 10 cm).

When this ban is in effect parking is prohibited on all town streets between 11 pm and 7 am to allow for snow clearing operations. Vehicles parked in violation of the ban will be ticketed and towed to the Public Library Parking Lot at 101 Beckwith St.
