

Tax Rebate Program for Registered Charities

A registered charity may apply for a tax rebate of 40% of Property Taxes on an eligible property it occupies in one of the commercial classes or industrial classes.

Who Qualifies?

A registered charity as defined in subsection 248(1) of the Income Tax Act (Canada) that has a registration number issued by the Canada Revenue Agency and pays taxes on an eligible property it occupies.

How the Program Works

- You must complete an application for this program **annually** to establish eligibility or confirm continued eligibility
- The deadline for submitting an application for the rebate is February 28th of the year following the taxation year to which the application relates
- The applicant must agree to provide the necessary information to the Town of Carleton Place in order to demonstrate that eligibility requirements have been met
