
EXISTING DECIDUOUS TREE





- This drawing shall be read in conjunction with all relevant drawings and specifications.
 - Architectural, Engineering and related Drawings and Specifications shall govern over all other drawings and specifications.
 - Refer to Engineering Drawings for Grading and Retention.
 - Contractor shall provide the location of all serviceabilities by consulting Municipal Authorities and provide protection during construction.
 - Plant material shall be No. 1 Grade and shall comply with the Canadian Nursery Trade Association (CNTA) standards.
 - Plant material locations are Schematic / Approximate only. Contractor shall verify and relocate on site prior to work.
 - Contractor shall guarantee all plant material for a period of 12 months from the date of installation.
 - Shrubs shall be planted in a continuous prepared bed of 450mm depth planting soil mix covered over with 75mm Penetrisable and Ornamental Grasses shall be planted in a continuous prepared bed of 450mm depth planting soil mix to finish grade.
 - Soil areas to receive 125mm topsoil. Soil shall be No. 1 quality conforming to the Canadian Nursery Sod Growers Association standards.
 - Restoration of all areas damaged or disturbed beyond the limit of work.
 - Protein based fertilizers shall not be permitted without written approval from the Consultant.
 - Contractor shall advise Consultant a minimum of 48hrs prior to any landscape work and any required Field Reviews.

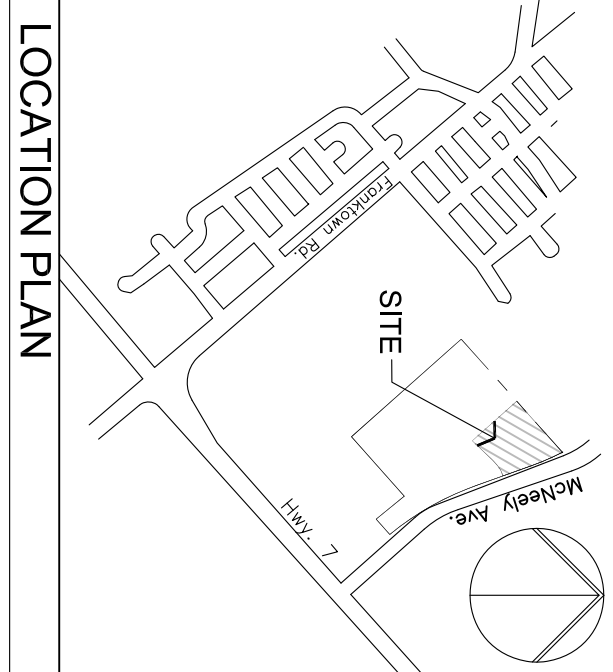
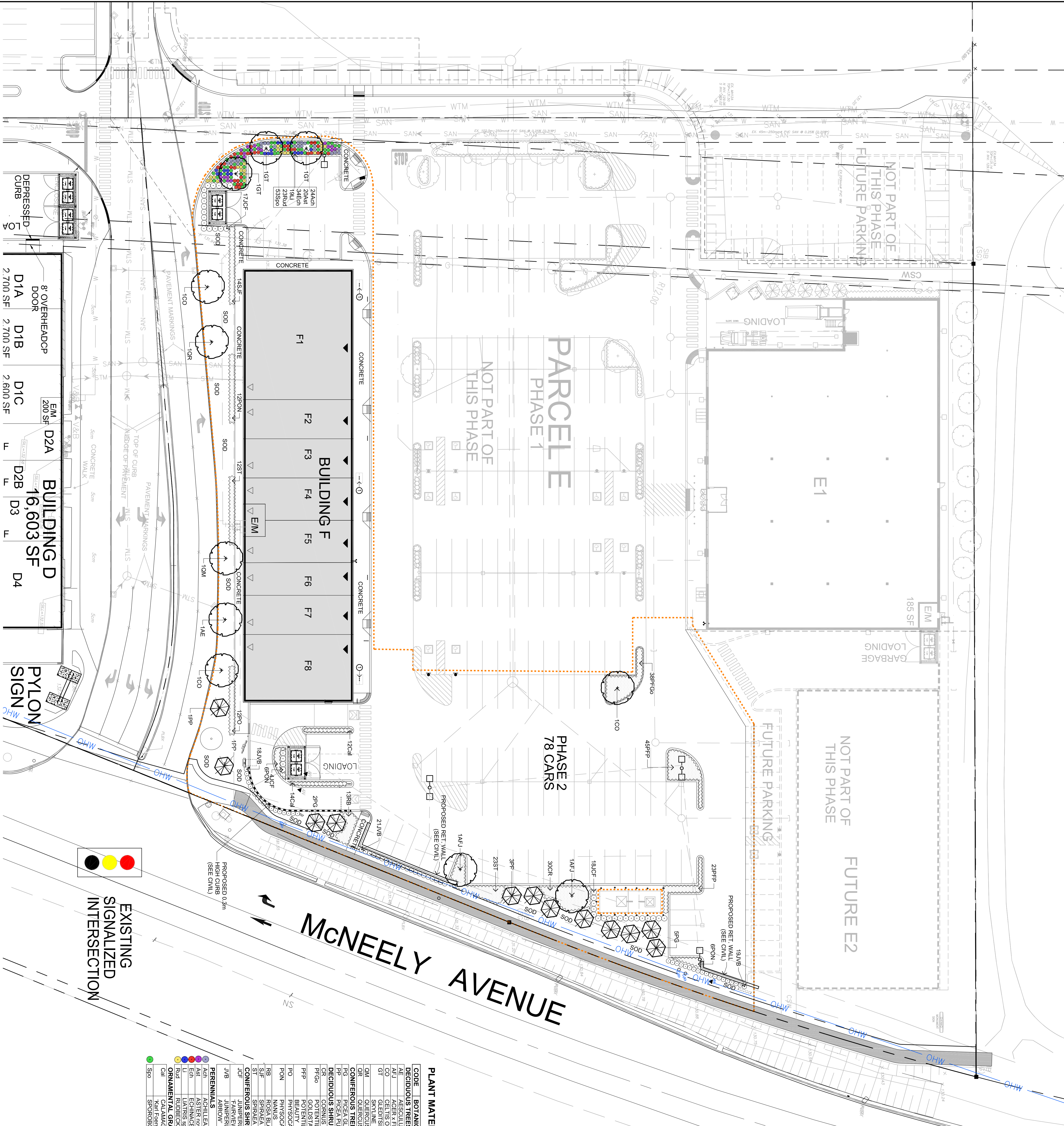
