BY-LAW 62-2025

A BY-LAW OF THE CORPORATION OF THE TOWN OF CARLETON PLACE TO AMEND TAX RATES BY-LAW 23-2025.

WHEREAS Section 312 of the Municipal Act, 2001 (S.O. 2001, c.25) provides that the Council of a local municipality shall after the adoption of estimates for the year, pass a bylaw to levy a separate tax rate on the assessment in each property class;

AND WHEREAS Section 312 (6) of the said Act requires tax rates to be established in the same proportion to tax ratios;

AND WHEREAS the Corporation of the Town of Carleton Place passed its Tax Rate By-law on April 22, 2025 which has to be amended to reflect the correct rates for the County;

NOW THEREFORE the Council of the Town of Carleton Place amends its tax rates as follows:

1. That the County Tax Rates be replaced as follows and applied to the taxable assessments of all properties in the Town of Carleton Place for 2025 as follows:
